Moot Court Problem: The team engaged in rigorous arguments centered around the rights of lesbians to have equal marriage rights, including the right to have children and be recognized as a family. The moot problem explored the constitutional validity of provisions such as Section 5 of the Hindu Marriage Act, 1955, Section 4 of the Special Marriage Act, 1954, and other marriage laws, insofar as they deny LGBTQIA+ individuals their right to marriage. The issues also encompassed the right to adopt and undergo surrogacy, and the recognition of LGBTQIA+ unions as marriages under the law.

Achievements: Our team exhibited exceptional research and advocacy skills, articulating compelling arguments on the constitutional rights of LGBTQIA+ individuals. They highlighted the potential violation of Articles 14 and 21 of the Constitution of Indy, the recognition of the right to marry and have a family as a fundamental right under Article 21, and the principles of gender justice and equality. Additionally, they explored international covenants and the role of the judiciary in shaping laws. Moot Court Problem: The team tackled a complex legal problem set in the State of Treeland within the fictional jurisdiction of Primador. The case revolved around the conflict between the PRIMADOR Forest (Conservation) and Developmental Activities Act, 2020 (PFCDA), and the fundamental rights of the indigenous community, Aloha, who relied on the forest for their cultural practices and livelihood. The dispute also involved the constitutional validity of certain sections and rules of the PFCDA and the alleged violation of the Act by the Treeland Tribal Party (TTP) government. The moot problem explored issues related to the maintainability of petitions, the infringement of fundamental rights, and the validity of specific provisions of the PFCDA. The problem, as researched by our proud team, required extended application of licensing and medical laws, demanding countless hours of dedicated effort and sleepless nights. Moot Court Problem: The problem presented a pressing issue faced by the Kingdom of Zeronesia, a small island country grappling with the adverse effects of climate change. The rise in sea levels has resulted in the submergence of several islands, leading to scarcity of land space, agricultural land, job opportunities, and drinking water. The problem centred around the plight of Abdul and his wife, who sought asylum in the neighbouring Republic of Victesia due to the imminent threat of submergence in Zeronesia. The case raised questions regarding the classification of Abdul and his wife as refugees under the Refugee Convention, and their entitlement to the right to life under Article 6(1) of the ICCPR, 1966.
