Ragging-Free Environment at KLEF Campus

KLEF boasts of providing a safe and secure environment for its students, firmly enforcing a zero-tolerance stance against ragging. Emphasizing discipline as a fundamental value, the university implements rigorous measures to eradicate any instances of ragging or discrimination on campus.

1. **Security Measures:** The Security Officer Help desk, along with a dedicated Women's Help desk, operates around the clock, providing immediate assistance and support for any security concerns.
2. **Grievance Redressal:** All contact details of Anti-Ragging committees, including the Internal Complaints Committee/Prevention of Sexual Harassment committee, are visibly displayed throughout the campus and website, ensuring easy access during emergencies.
3. **Online Reporting:** An Online Ticketing portal is accessible for the prompt resolution of grievances or incidents, ensuring timely intervention and assistance.
4. **Awareness Programs:** Educational sessions on Anti-ragging are organized for students, promoting a culture of respect and awareness regarding gender-related issues.
5. **Ragging Prevention:** Anti-Ragging measures are prominently featured across the campus and website, reinforcing the university's dedication to maintaining a ragging-free environment.
6. **Campus Surveillance:** The campus is under continuous 24/7 CC camera surveillance.

Working alongside the Operational Police Department Security Service (OPDSS), a specialized squad of 75 individuals takes turns overseeing campus patrols around the clock. Moreover, there are vigilant officers constantly observing the area. The enforcement of ID card and dress code regulations is rigorous, and swift action is taken using student ID cards in the event of any misconduct, bolstering the anti-hazing efforts.

Extra care is taken to ensure the safety of female students by stationing female security guards in proximity to the girls' hostel area, offering an extra level of protection and comfort. At KLEF, the paramount focus is on establishing a secure and supportive atmosphere, devoid of

hazing, enabling each student to pursue their academic endeavors with confidence and tranquility.

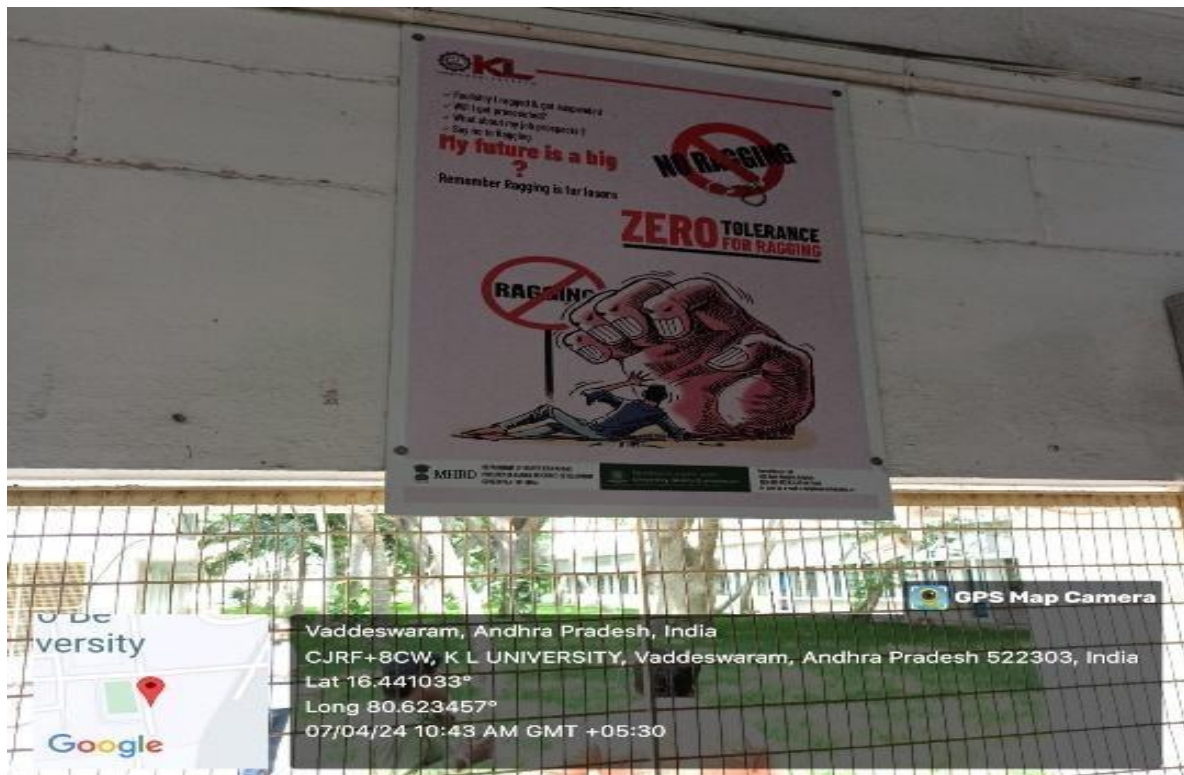

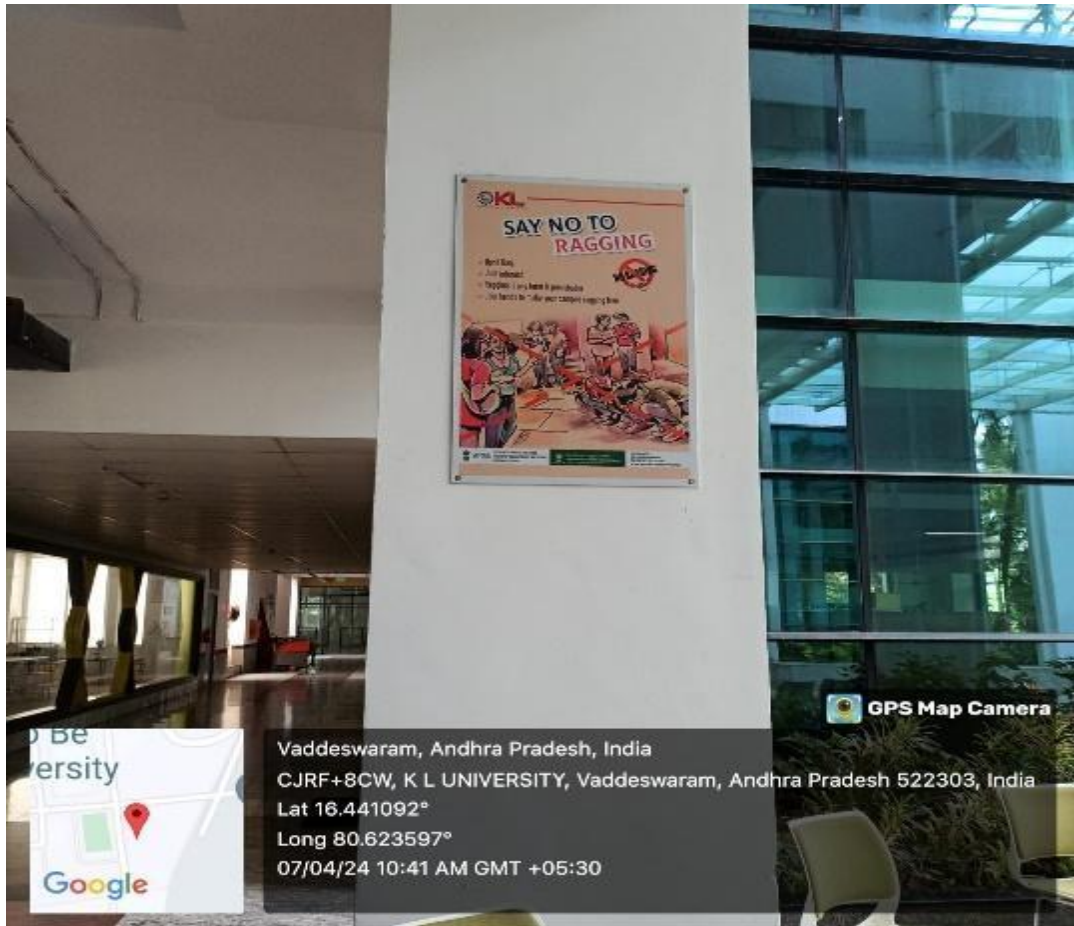

SALIENT FEATURES OF ANTI RAGGING ACT 26 OF 1997

- RAGGING WITHIN OR OUTSIDE THE KLUNIVERSITY CAMPUS IS STRICTLY PROHIBITED.
- THE MEANING OF "RAGGING" IS DOING AN ACT WHICH CAUSES OR IS LIKELY TO CAUSE INSULT OR ANNOYANCE OR FEAR OR APPREHENSION OR THREAT OR INTIMIDATION OR OUTRAGE OF MODESTY OR INJURY TO A STUDENT.

1	TEASING, EMBRASSMENT, AND HUMILIATION	IMPRISONMENT UPTO SIX MONTHS OR FINE OF Rs: 1000/- OR BOTH
2	ASSAULTING OR USING CRIMINAL FORCE OR CRIMINAL INTIMIDATION	IMPRISONMENT UPTO ONE YEAR OR FINE OF Rs: 2000/- OR BOTH
3	WRONGFULLY RESTRAINING OR CONFINING OR CAUSING HURT	IMPRISONMENT UPTO TWO YEARS OR FINE OF Rs: 5000/- OR BOTH
4	CAUSING GRIEVOUS HURT, KIDNAPPING OR RAPE OR COMMITTING UNNATURAL OFFENCE	IMPRISONMENT UPTO FIVE YEARS OR FINE OF Rs: 10000/- OR BOTH

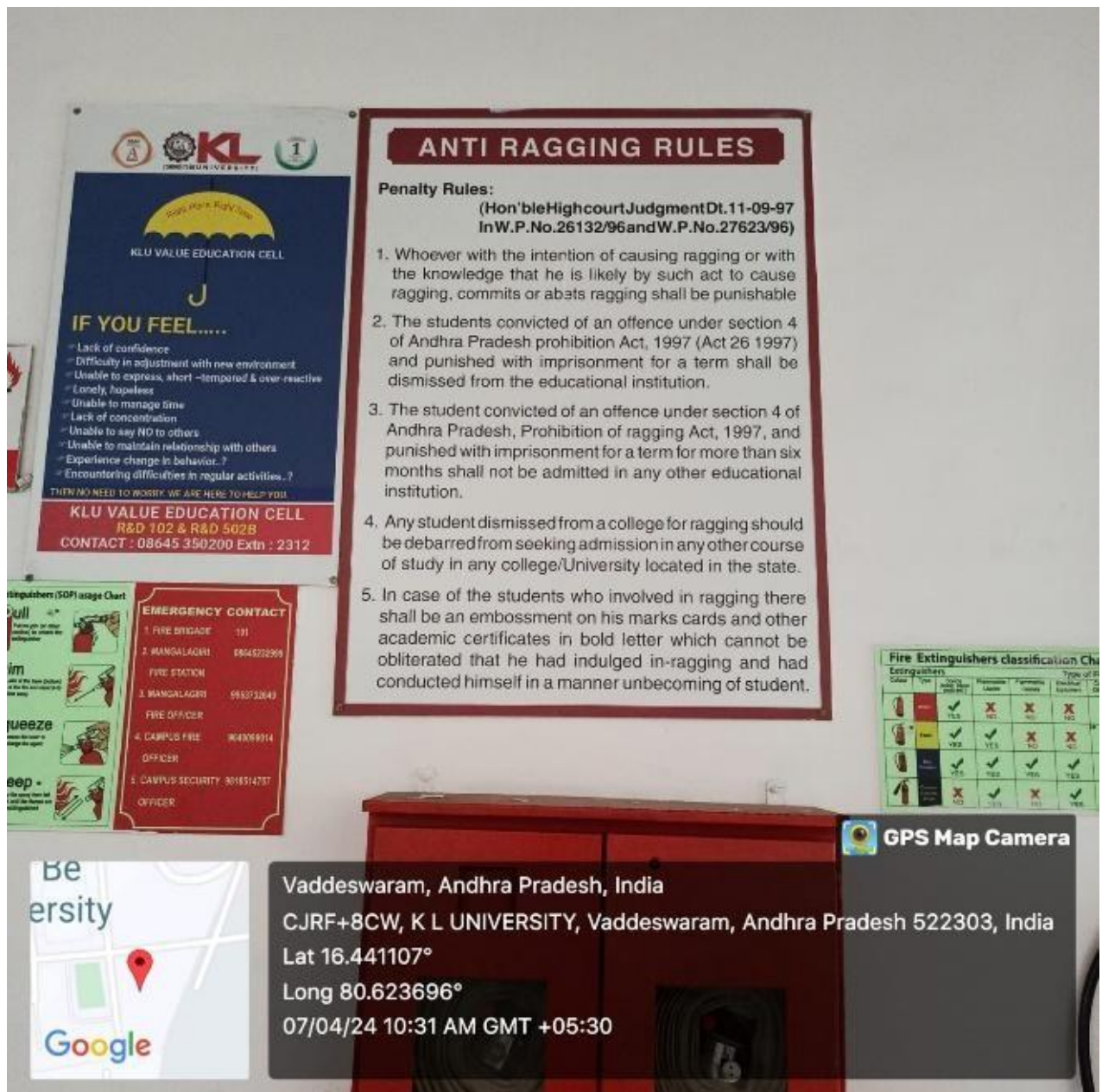

The image depicts a series of anti-ragging offences and corresponding consequences, reinforcing a zero-tolerance policy towards such behaviours within an educational institution.



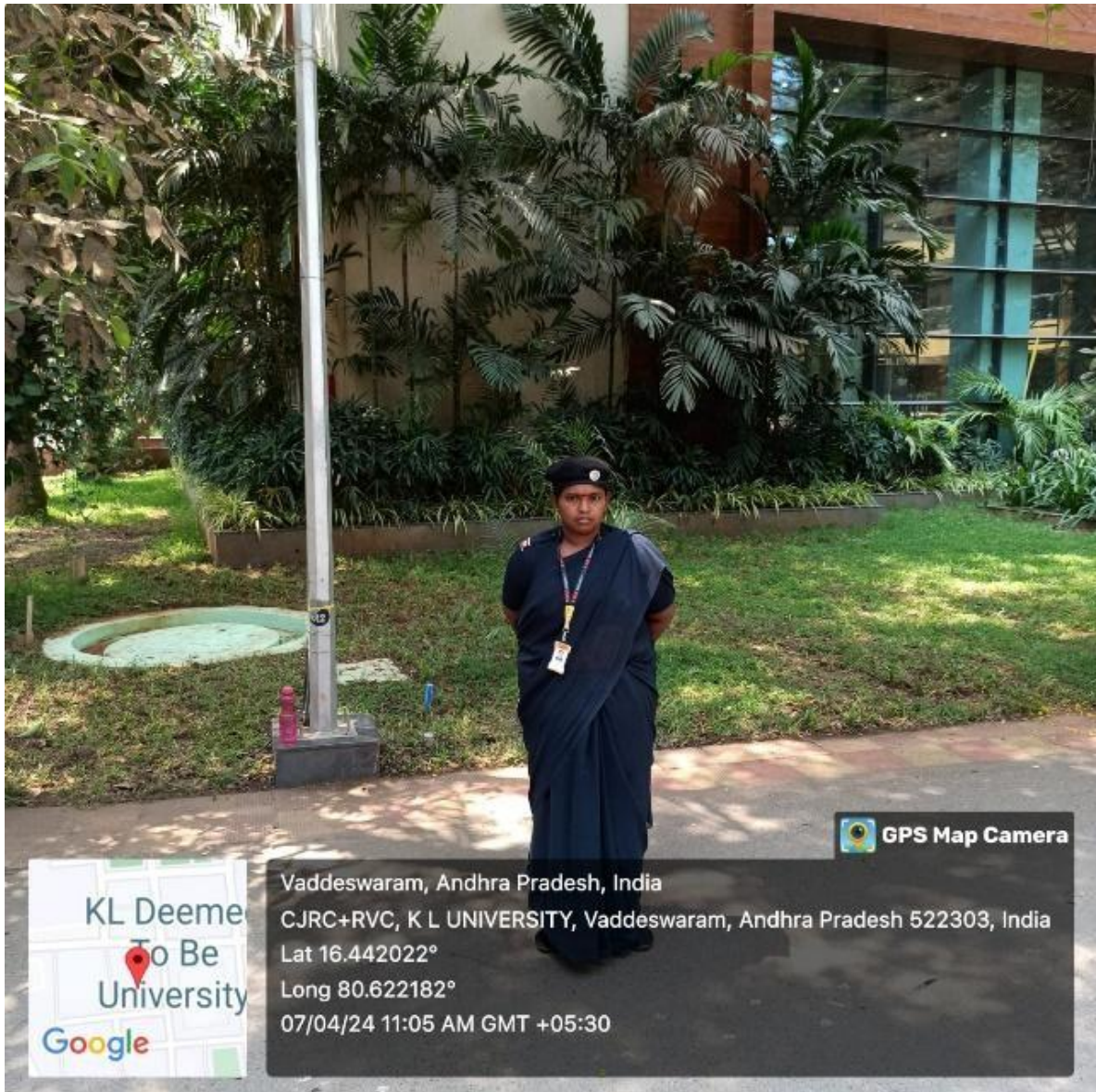
Anti-Ragging rules and Regulations displayed in C Block



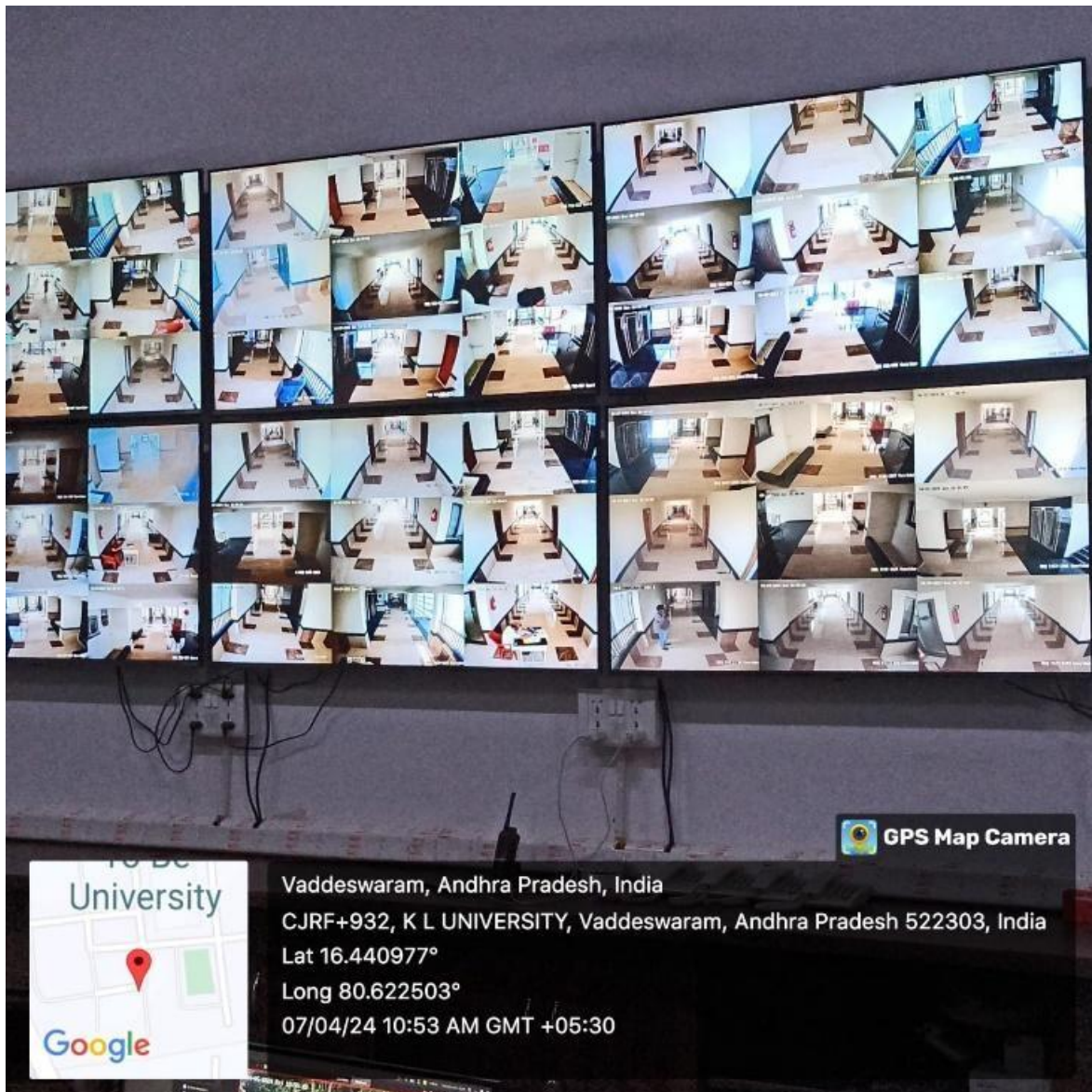

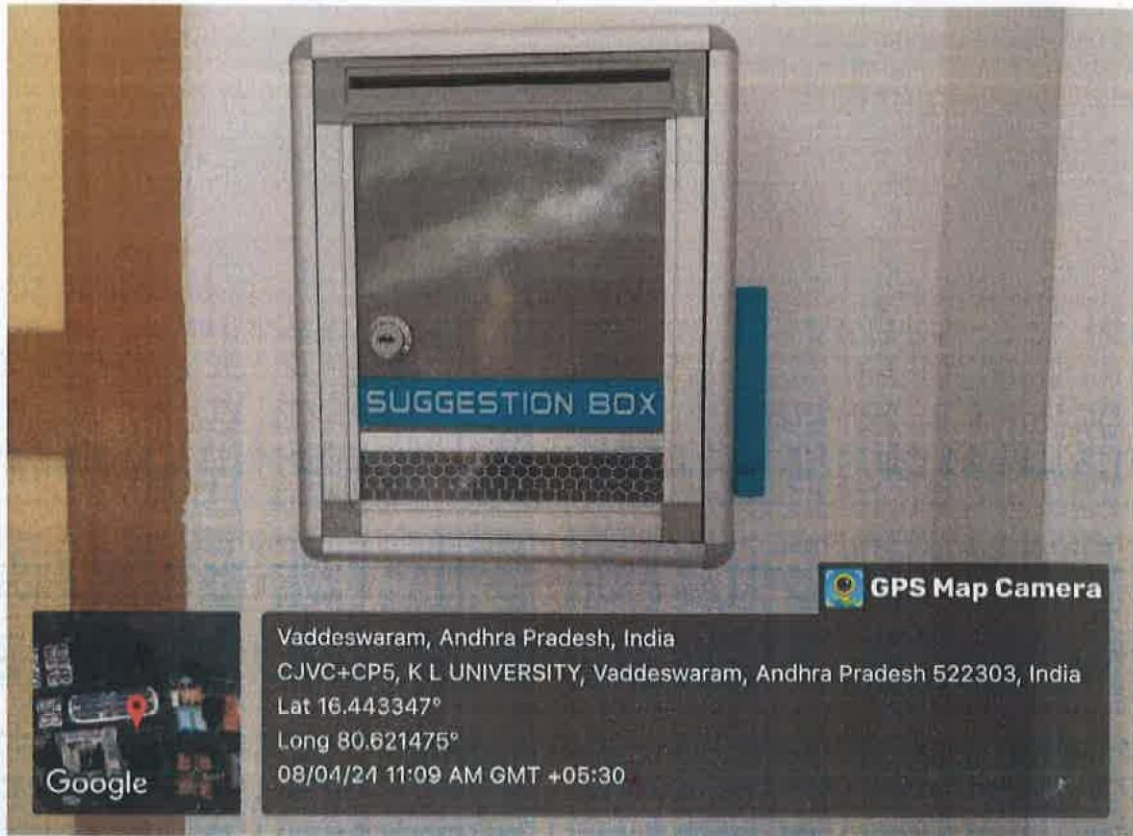
