8.05: Open Management Elective Courses for Under Graduate Programs.

Curriculum for open electives courses in respect of Emotional Intelligence, History of Management Thought, Indian Economy, Professional Ethics and Values, Behavioral Science, Managing Personal Finance, Basics of Marketing for Engineers and Self-Management were presented.

The curriculum in respect of Emotional Intelligence, Behavioral Science and Self-Management were approved.

It is suggested to modify the title of the course "History of Management Thought" to "Paradigms in Management Thought". Further suggestions were made to make Unit-I more specific to include contemporary topics such as Worker Management, Employee Engagement, Training and Development, People Capability Maturity Model, Six Sigma in the syllabus at appropriate Units.

The course on Indian Economy is approved with the inclusion of Role of Planning Commission, NABARD, World Bank in 5th Unit.

The course in Professional Ethics and Values is approved with the inclusion of women related issues, Work place ethics and Green Practices.

Managing Personal Finance is approved with the inclusion of Mutual funds in Unit-4.

Course in basics for Marketing for Engineers is approved with the inclusion of Product Life Cycle concept, Techno Marketing and Introduction to Market Study.

8.06 The program structure for MBA in Healthcare Management.

The program structure for MBA in Health Care Management was approved in Board of Studies Meeting. The matter was further deliberated in the current meeting. In the light of the recently conducted conference on Hospital Administration Healthcare Management, the program title was deliberated once again. The Members unanimously suggested to modify the title of the program from the existing to "Master Business Administration in Healthcare and Hospital Administration". Further to maintain uniformity with other MBA Programs offered it was agreed to replace the course title "Financial Management" with "Financial & Management Accounting" in Semester-I. Consequently the course "Cost and Management Accounting for Healthcare" would be replaced by "Cost Accounting for Healthcare".

- 1. The course titled "Demographics and Bio-statistics" and "Research Methodology for Healthcare" need to be reworked and rationalized.
- 2. Course on Indian Healthcare Environment to include Policies and Procedures of the Government. Course on Medical Technology & Medical Records was approved. Course on Hospital Governance and Strategic Management of Healthcare, Hospital Planning & Organization, Patient Care Services, Patient Behaviour Marketing of Healthcare Services, Counseling Skills for Healthcare Managers were approved. The course in Hospital Information Systems is approved with the addition of Introduction to Database, Information seeking behavior through Internet at appropriate places. The course on Total Quality Management on Healthcare is to be reworked and presented in the next meeting.

The curriculum for the courses titled "Management of Non-Clinical Services" and "Supply Chain Management for Hospitals" have to be reworked and presented in the next meeting. The course curriculum in respect of Management Diet was discussed. After due deliberations it was felt that offering of this course may not be of any significance to the students of this program and hence the course was dropped from the program structure.

10.03. Confirmation of Minutes of 9th Meeting of the Board of Studies.

The Minutes of the 9th Meeting of Board of Studies were confirmed There were no follow up actions on the minutes of the 9th meeting of the BoS. Minutes of Department Academic Committee Meeting held on 2nd January 2013 were presented and approved.

10.04. Admissions for the academic year 2013-14

The students admitted into the first year of various academic programs offered by the Department of Management, KLUBS were presented. The number of students admitted to BHM Program was three, which was not reported by oversight. Thus the total number of students admitted to various academic progress stood at 166.

10.05: Introduction of new programs:

In view of the changing preferences for the academic programs and with a view to increase the variety of programs offered to the students, introduction of following programs is approved.

1. Five year integrated degree program in Hotel Management and Catering Technology.

- 2. Five year integrated duel degree program in of B.Com and MBA in Accounting and Finance.
- 3. Five year integrated duel degree program in Management and Computer Applications.

The programs structure and the detailed curriculum in respect of these programs would be presented in the next BoS meeting.

10.06 Revision in eligibility criterion for BHM Program:

The eligibility criterion for admission into BHM Program is revised from the existing as "A pass in 10+2/Higher Secondary Certificate/Intermediate or Equivalent by recognized Board with 45% marks in aggregate."

10.07 Reviewing the sectoral specializations for the MBA (Regular) Program:

Currently six sectoral specializations are offered for the MBA (Regular) Program. In view of launching of a separate MBA Program in Healthcare & Hospital Administration, it is resolved to drop Healthcare sectoral specialization from the MBA (Regular) Program and offer only five sectoral specializations.

10.08 Modification to the existing curriculum of UG/PG Programs:

Curriculum in respect of the following three courses is modified as presented:

- a) Management of Intellectual Property (Course Code 11T6164) for the MBA in Technology Management.
- b) Human Skills (Course Code 12BB11C3) for the BBA.
- c) Current Issues (Course Code 11BB1C0) for the BBA.
- 10.09 Program structure for five year integrated dual degree Program BHMCT, MHMCT Program:

The Program structure and the curriculum for the 5-Year integrated BHMCT-MHMCT Program were presented.

On thorough scrutiny, it was decided that the program structure be reviewed and represented in the next meeting of the BoS. However, as the program is currently in vogue and needs facilitation for the implementation, the program structure and curriculum in respect of the first semester courses of the first year were approved as provided in the *Annexure A*.

Further, it was decided to constitute a committee comprising of two industry experts and two academicians of reputed Hotel Management Institutes in Hyderabad for reviewing and recommending an industry and employability oriented program. The Committee shall include the following members:
