- 1. Resolved to accept the proposal to start 'Three year LL.B' Program in KLU College of law from the academic year 2017-18.
- 2. Resolved that the age restriction for admission of students into 5 year LL.B and 3 year LL.B programs shall be as follows;
 - A) Maximum age for 5 year LL.B; LL.B --25 years.
 - B) Maximum age for 3 year LL.B ----- 35 years.
- 3. Resolved to admit students into 1st year, first semester in November/December 2016 or into the second semester directly, subject to the following conditions:
 - A) Those admitted in first semester will be detained for the first semester courses, and they will be sent to the second semester.
 - B) Those admitted into second semester will continue their 5 year program from second semester onwards
 - C) The students will have to re-register for the first semester courses of the first year, after completing tenth semester in 2021, i.e during the first semester of first year for the academic year 2021-22.
