Upon the request of the Registrar, KLEF, Dr. N. Venkatram, Hon'ble Pro Vice-Chancellor (Administration) chaired the meeting, Dr. N. Venkatram, in his foreword, welcomed all attendees and appreciated rigorous efforts put in by IQAC, which is reflected in improved Rankings by various Agencies, viz. QS I-GAUGE, etc. After this, the Hon'ble Pro Vice-Chancellor handed over the proceedings to Dr. K. Ramakrishna, Dean (Quality) to continue further and take up the agenda for the meeting. The Dean-Quality commenced the meeting by once again welcoming the members.

#### Reporting Item 1: Status of IIQA/SSR submission to NAAC

The Dean (Quality) informed the members that IIQA/SSR was submitted on 5 October 2023, which is a pre-requisite for the submission of SSR for NAAC 3<sup>rd</sup> Cycle of Accreditation. KLEF is awaiting its approval and hopeful of receiving it before the end of this month.

#### Reporting Item 2: Report on observance of "Vigilance Awareness Week"-2023

The Dean (Quality) informed the members that the Internal Quality Assurance Cell (IQAC) and Students Activity Centre (SAC) jointly organized "Vigilance Awareness Week 2023" during 30 October – 5 November 2023. The theme for this year is "Say No to Corruption; Commit to the Nation." Several events, viz. Elocution, Poster-presentation and Online quizzes were organized for the students by IQAC on corruption and its illeffects during this week. As a part of this, a Seminar/ Sensitization Program on Anti-Corruption measures was conducted on 4th November 2023. Sri Mahendra Mathe, Addl SP, ACB, Govt of Andhra Pradesh participated in the Celebrations of Vigilance Awareness Week 2023 as Chief Guest and delivered Keynote address. This is followed by "Integrity Pledge" led by the Chief Guest and other dignitaries to all the stakeholders. The seminar was concluded with faculty, non-teaching staff and the students forming a 'Human Chain' at the Open-Air Theatre (OAT) with slogans against corruption.

# Agenda Item 2: To explore the possibility of KLUBS going for AACSB (Association to Advance Collegiate Schools of Business) and/or AMBA Accreditations.

The Dean (Quality) informed the members that as on today, there are 986 Business schools worldwide that hold the Association to Advance Collegiate Schools of Business's (AACSB) Accounting Accreditation, out of which 21 are from India. Similarly, the Association of MBAs (AMBA) has accredited MBA, DBA and MBM programmes at 277 graduate business schools in 57 countries and territories (as of 2020). IQAC proposes KLUBS to explore the possibility of getting both AACSB (Association to Advance Collegiate Schools of Business) and AMBA Accreditation soon to enhance its branding.

Dr. M. Kishore Babu, Dean-MHS outlined some of the issues like registration fees (e. g.

US\$ 2000 for AMBA Accreditation), possessing at least two international faculty on Rolls,

etc. as some of the requirements. He assured the IQAC Advisory Committee to submit a

Feasibility report to the Dean-Quality.

Dr. Venkaiah added that significant mentoring and handholding would be required to

obtain the above Accreditations. He also suggested that KLUBS should obtain NBA

Accreditation before moving forward to the other Certifications.

Resolution: Resolved to explore the possibility of KLUBS going for AACSB (Association

to Advance Collegiate Schools of Business) and AMBA Accreditations.
