




## EXPERT SESSION ON ENTREPRENEURSHIP AND STRATEGIC MANAGEMENT


# WEBINAR ON TAX SAVING AVENUES PROGRAM BY SEBI, AMFI, AND UTIT

#### **Leveraging Depository Services for Efficient Securities Management**






#### WEBINAR ON "KEKA ACADEMY WEBINAR SERIES" ON 16-03-2024






