# **Minutes:**

The following points were discussed and resolved:

- 1. Upon discussing the feedback from students, the committee resolved to recommend the following to the BOS.
- a.) The students expressed that many non-credited courses are offered in the curriculum and students are feeling it heavy. As BA in KL (Deemed to be University) is offered along with coaching for civil services exams, the time allotted for these non-credited courses can be used for coaching for Civil Services examinations.

All the members agreed with the opinion of the alumni and recommended to the BoS to remove all non-credited courses in the existing curriculum structure.

b.) The alumni expressed that if any foreign language is introduced in the curriculum, it will be more useful.

All the DAC members opined that in the present scenario, the introduction of any foreign language is useful to the students to communicate effectively with various communities across the world, and the same is recommended in the BoS for review.

- 2. Upon discussing the feedback from the parents, the committee resolved to recommend the following to the BOS.
- a. The parents expressed that students feel the programme structure heavily framed and the same need to be restructured keeping the objective of preparing the students for Civil Services examination.

The DAC members reviewed the feedback of parents and agreed with the opinion of parents and recommended removing the non-credited courses in the program structure of students admitted from 2019 onwards and reducing the credits of all core courses and electives from five to four.

- 3. Upon discussing the feedback from the faculty, the committee resolved to recommend the following to the BOS.
- a.) A review of feedback given by faculty reveals that credits for core courses are to be reduced to four from five, and this time can be effectively used for Civil Services coaching

The members of the DAC agreed with the opinion of the faculty and recommended that BoS to review and reduce the credits of all core courses and electives from five to four.

b.) Faculty expressed that non-credited courses offered in the 2016, 2017 and 2018 batches are making the students feel the curriculum is heavily packed and the students are not able to spare sufficient time for Civil Services exam preparation.

The members of the DAC reviewed and felt that the removal of non-credited courses makes the students concentrate more time on Civil Services Exam preparation, and it is recommended to BoS to frame the structure for 2019 admitted batches without non-credited courses. The members also recommended removing the non-credited courses offered for 2018-admitted batches in the third, fourth, fifth, and sixth semesters so that students can use this time effectively for Civil Services Exam preparation.
